1. You are invited to submit your most competitive quotation for the following goods:-

2. **Bid Price**

- 2.1 The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- 2.2 All duties, taxes payable by the contractor under the contract shall be considered in the quoted price indicating the breakup value.
- 2.3 a) The bidder should furnish the CIF value of the imported component with Customs duty separately in the price bid in addition to the other breakup value packaging & Forwarding, Inland transport, Installation and commissioning and other incidental charges

b) The bidders are advised to take in to consideration the savings available due to abolition of CVD and SAD for imports now due to GST implementation, and consider the benefits out of it as a reduction, while arriving at their bid price.

c) Similarly, the benefits that could be availed out of High Sea Sales/ Sales in course of import should also be considered as a reduction while arriving at their bid price.

d) GST shall be indicated separately.

2.4 The Prices should be quoted in Indian Rupees only.

3. Each bidder shall submit only one quotation.

3.1. Earnest money deposit:-

a. Earnest money deposit:- Each quotation should be submitted with an EMD of Rs.1,000/- by means of DD drawn in favour of "Tamilnadu Medical Services Corporation Limited, Chennai payable at Chennai.

b. Domestic Micro and Domestic Small Enterprises located within the State of Tamil Nadu which manufacturers or provides the goods, provides or render the services within the State and registered with State MSME authorities in appropriate manner, as prescribed from time to time alone are eligible for exemption from payment of Earnest Money Deposit against the production of copy of the applicable registration document.

c. All other Enterprises are not eligible for claiming EMD exemption and hence to remit the EMD amount with their tender.

d. The domestic Micro and Small indicates bidders who claims exemption form the payment of EMD shall submit an undertaking in the following format signed by the Authorized to Signatory of the bidder.

3.2 Quotation received without EMD amount will be treated as non-responsive.

3.3 The bidder should furnish the GST registration no. for supply and services and the code no. for the goods quoted.

3.4 The GST registered bidders are only eligible to participate in the quotation.

3.5 The bidder should furnish the details of Bank name, Branch name, Account no., IFSC code and a copy of cancelled cheque leaf.

3.6 Domestic Enterprises (i.e., from Tamil Nadu) who is the manufacturer of the tendered product within the state and Micro and Small Enterprises registered with MSME are eligible for EMD Exemption, otherwise not eligible.

4. **Validity of Quotation:-**

Quotation shall remain valid for a period not less than 45 days after the deadline date specified for submission.

5. **Evaluation of Quotations:-**

5.1 The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

(a) are properly signed; and

(b) conform to the terms and conditions, and specifications

(c) Not furnishing Catalogues, Point wise compliance statement of Technical specification, and producing the sample of the quoted item for demo within one week notice, if called for would be treated as a violation of the terms of the tender and the bids would be treated as non-responsive.

6. **Award of contract:-**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

6.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

6.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

6.3 For delay in supply of the goods beyond the stipulated delivery period, liquidated damages at 0.5% per week or part thereof

- of undelivered portion of the contract, subject to a maximum of 10% of the contract value is leviable.
- 6.4 You shall furnish performance security for 5% of contract value by means of demand draft drawn in favour of Managing Director Tamilnadu Medical Service Corporation Limited Payable at Chennai which will be returned after satisfactory completion of warranty period.
 - 6.5 Payment shall be made within 30 days after delivery of the goods, against submission of bills with certification from the consignee for satisfactory completion of supply.
 - 6.6 The item supplied shall carry a warranty of atleast 3 years for equipment from the date of acceptance of the goods by the consignee.

Specifications of Equipment & Interior Fabrication / Fittings

Specification of Equipment

- 1 Air conditioner (Quantity – 1 No.)
 - Roof-mounted split AC of 1.5 ton capacity.
 - AC to run on 230 ± 10V, AC, 50/60 Hz supply. The line cord / Power cord supplied with the equipment shall be of acceptable durability, length and current carrying capacity complying with Indian Standards.
 - Standard Make.
- 2 Noiseless portable **Generator set (5 KVA)** – Quantity – 1 No. – running on petrol/diesel and conforming to Central pollution board norms.
 - Equipment to power include :Dental Chair and accessories along with X-ray unit, Compressor, Autoclave, Internal lighting, Mobile X-ray, laptop, printer, AC unit, UPS etc.,
 - Provision for a 20L petrol/Diesel canister to be secured outside the vehicle.

II. Technical Specifications for Fabrication / Interiors of Van

• **Interior**

- Full partition behind driver
- Homogeneous non- static, anti – skid vinyl flooring material with water proof ply - board.
- Providing instrument cabinet, nurse stool & grab rails.
- Providing wash basin and cupboard

• **INSIDE FINISHING**

- 22 swg galvanized sheets all over.
- Homogenous non- static, mark resistant, anti –skid vinyl flooring material with water proof ply- board.
- Thermacol insulated body panel walls, door and ceiling

• **PAINTING**

- Inside painting with synthetic paint in desired shade.

• **ELECTRICALS**

- Extra cable of 20 ft. to get power from outer source will be provided
- Water motor at outside body with overflow pipe will be provided.

- Sufficient power ports wherever necessary.
- Sufficient no. of LED lights & Fans will be provided inside.
- Revolving lamp on top, head lamps, tail lamps, signal lights.
- All Electrical wiring and AC/DC connection is ISI mark suitably covered with PVC sleeves
- **GENERAL**
 - Fresh water tank (appx. 300 ltrs) at the top of the vehicle and waste water tank at the bottom of the vehicle.
 - Grab rail on door for easy access.
 - Utility cabinets will be provided as per space available.
 - All other fitments like I.V. hooks, brackets with belts, reflectors, magazine pouch, M.S. holding bars, PVC Grab handles, mud flaps, mobile holder with charger, etc. as per our standard practices and TRO rules and regulations.
 - First -aid kit , fire extinguisher, front and rear number plate etc
 - Retractable / pull out awning from both side of vehicle and foldable.
 - College Name and Department Name and LOGO to be painted on Both Sides and in front.
 - To write "Mobile Dental Clinic" in front.
- **Provision with wiring and required power point** for the following equipment:-
 - Two nos. of fully electrically operated programmable dental chair unit with the sensor operated light
 - Noiseless oil free compressor
 - X- ray unit for 1 chair
 - Electric Scalar 3 detachable hand piece
 - Cordless light cure unit
 - Front loading autoclave with drum
 - Hot water boiler
 - Micro motor marathon with straight & contra angle handpiece.
 - Utility tray
 - 1.5 Ton split AC and condenser outside the body below floor level.
 - 5 KVA Generator outside the body below floor level
 - Awning (Retractable Canopy) on the both sides of van and foldable.

- Ultrasonic Cleaner.
- All electrical points and other connections to be positioned on the wall of the vehicle.
